



**PROCORE STATE OF ORIGIN III 2025 SYDNEY BOX GIVEAWAY
OFFICIAL RULES**

No purchase is necessary to enter or win. A purchase or payment will not increase your chances of winning.

This promotion is not sponsored, endorsed, or administered by, or associated with, Oliver Kinross Ltd. or Sydney Build.

1) SPONSOR. Procore Technologies, Inc., 6309 Carpinteria Avenue, Carpinteria, CA 93013 USA is the “**Sponsor**”. The Promotion is not sponsored by, endorsed by, administered by, or affiliated with Facebook, Instagram, Twitter, or any other social media platform on which it appears.

2) ELIGIBILITY. Procore State of Origin III 2025 Sydney Box Giveaway (the “**Promotion**”) is open only to legal residents of Australia (excluding the Australian Capital Territory) who are 18 years of age or older at the time of entry (each, an “**Entrant**”). The Promotion is void outside of these territories, and where prohibited, taxed, or restricted by law. Employees, officers, and directors (and their immediate families and members of their households, whether or not related) of (i) Sponsor and Sponsor’s subsidiaries, affiliates, partners, advertising and promotion agencies, manufacturers, or distributors of Promotion materials (collectively, the “**Promotion Parties**”); or (ii) government in any country are not eligible to participate in the Promotion. Winning a Prize (defined below) is contingent upon Entrant fulfilling all requirements set forth herein and is subject to compliance with all applicable federal, state, and local laws and regulations.

3) PARTICIPATION. Participation in the Promotion constitutes Entrant’s full and unconditional agreement to be bound by these “**Official Rules**” and by Sponsor’s decisions, which are final and binding in all matters related to the Promotion. These Official Rules supplement any terms set forth in any email, website, or social media post. By submitting an Entry (defined below), the Entrant agrees to these Official Rules and warrants that the Entry complies with all requirements set out in these Official Rules.

4) ENTRY. To enter the Promotion, take one of the following actions (each an “**Entry**”):

- a. Scan your badge at the Procore booth at Sydney Build Expo 2025; or

Each Postal Entry must clearly include the Entrant's full name, residential address, phone number, and email address (if applicable). Only one (1) entry per postcard or letter is permitted. Multiple entries submitted in the same envelope will be disqualified. Sponsor accepts no responsibility for lost, late, or misdirected Postal Entries. The cost of postage is the sole responsibility of the Entrant submitting the Postal Entry.

All Entries become the sole and exclusive property of Sponsor. Sponsor is not required to return or acknowledge any Entry. By participating in the Promotion, Entrant warrants that Entrant has the authority to grant the rights described herein to Sponsor, and that the information submitted to the Sponsor is true, correct, and complete in all material respects and is not misleading. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, or garbled entries, which may be disqualified in Sponsor’s sole discretion.

5) TERM. The Promotion begins on 7 May 2025 at 9 a.m. Australian Eastern Time and ends on 21 May 2025 at 11:59 p.m. Australian Eastern Time, and all Postal Entries must be received by Sponsor no later than 21 May 2025 at 11:59 p.m. Australian Eastern Time. Any entries received after this time will be deemed invalid. (the “**Promotion Period**”). **All Entries must be received before the end of the Promotion Period.** Winner(s) will be selected on or around 22 May 2025. Sponsor’s designated clock is the official clock of the Promotion.

6) **PRIZE.** The winning Entrant will receive one (1) double pass (which includes two (2) tickets) to Procore's corporate box at the Sydney Men's State of Origin Game on 9 July 2025 (the "**Prize**"). The total approximate retail value of the Prize is \$3,400 AUD. For purposes of clarity, the costs of all travel and accommodation expenses for the Sydney Men's State of Origin Game shall not be included in the Prize, and all costs are the sole responsibility of the Winner. Winner is responsible for obtaining any necessary travel documents at Winner's expense. Sponsor is not responsible for cancellations or delays of the flights or Winner's failure or inability to timely secure required travel documents. The Prize will be awarded following the close of the Promotion Period, at a time and in a manner determined at Sponsor's sole discretion. No substitution, cash equivalent, or transfer of a Prize is permitted except at Sponsor's sole discretion. Sponsor reserves the right to substitute a Prize (or a portion thereof) with one of equal or greater value. Prizes are subject to and winners must abide by all requirements of these Official Rules. Winners agree to accept any Prize "as is." The Sponsor has sole discretion to resolve any concerns, questions, or complaints related to a Prize. Prizes may be subject to additional terms and conditions imposed by the issuer of the Prize.

7) **SELECTION OF WINNERS.** Winners will be selected by random drawing from all eligible Entries on or around 22 May 2025 at Sponsor's offices in Sydney, NSW. The odds of winning depend on the number of eligible Entries received during the Promotion Period. Sponsor's decisions are final in all matters, including determination of the Promotion winners, interpretation of these Official Rules, and awarding of a Prize. **Even if your Entry qualifies you as a potential winner at the close of the Promotion, you have not yet won a Prize. Potential winners are subject to verification by Sponsor, and must meet all eligibility requirements before being confirmed as the winner.** The winner grants the Sponsor the right to publish their name, photo, and place of residence (city/town only). Winners may be required to provide additional information for the proper processing of the award of a Prize.

8) **NOTIFICATION.** The potential winner will be notified by email or mail, in Sponsor's sole discretion, at the email address or physical address provided at the time of Entry. Potential winners must claim their prize by responding to the notification within five (5) business days. If the potential winner does not respond; or if notification to the potential winner is returned as undeliverable; or if a potential winner rejects their Prize; or if a potential winner does not comply with these Official Rules, that potential winner will forfeit their Prize and an alternate winner may be selected. The potential winner may be required to execute: an affidavit, declaration, or certificate of eligibility; a liability release; and a publicity release; and to provide proof of identification (e.g., driver's license, passport). If the potential winner: does not execute and deliver any required documents to the Sponsor by the specified deadline; rejects a Prize; does not comply with these Official Rules; that potential winner may be disqualified from the Promotion, and Sponsor may select an alternate potential winner (up to a maximum of 1 alternate). 10) **USE OF ENTRY.** Except where prohibited by law, entry in the Promotion constitutes Entrant's irrevocable permission for Sponsor to use the Entry, including Entrant's name, picture, character, likeness, and voice as they may appear in the Entry, for trade, advertising, promotional, or any other purpose, throughout the world in any media now known or hereafter developed, without notice or compensation.

11) **RIGHT TO CANCEL OR SUSPEND PROMOTION.** If the Promotion is not able to run as planned due to infection by computer virus, bug, worm, trojan horse, denial of service attack, tampering, unauthorized intervention, fraud, technical failure, or any other cause that corrupts or affects the administration, security, fairness, integrity, or proper conduct of this Promotion, or any other reason, the Sponsor may, in its sole discretion, choose to

cancel, terminate, modify, or suspend the Promotion. In such case, Sponsor may select the winner from all eligible Entries received prior to the occurrence of the interfering event. Sponsor may, in its sole discretion, disqualify any Entrant Sponsor suspects of tampering with the entry process or the operation of the Promotion. Sponsor may prohibit an Entrant from participating in the Promotion or winning a Prize if, in Sponsor's sole discretion, Sponsor determines that Entrant is attempting to undermine the legitimate operation of the Promotion. 12) **TECHNOLOGY TERMS AND CONDITIONS.** Sponsor is not responsible for incomplete, misdirected, late, lost, damaged, or stolen Entries; or for lost, interrupted, inaccessible, or unavailable networks, servers, satellites, internet service providers, websites, or other connections; or for miscommunications, failed, jumbled, scrambled, delayed, or misdirected computer, telephone, or cable transmissions; or for technical malfunctions, failures, or difficulties, printing errors, clerical, typographical, or other errors in the offering or announcement of any Prize or in any Prize notification documents, or other errors of any kind or nature; or for the incorrect or inaccurate capture of information, or the failure to capture any information.

13) **ACCOUNT HOLDER.** The person submitting the Entry must be the Authorized Account Holder of the email account used to submit the Entry, otherwise the Entry may be deemed void. **"Authorized Account Holder"** means the natural person who is assigned an email address by an internet access provider, online service provider, or other organization (e.g., business, educational, institution, etc.) responsible for assigning email addresses or the domain associated with the submitted email address. A potential winner shall, at Sponsor's request, provide Sponsor with proof that the potential winner is the Authorized Account Holder of the email address associated with the winning Entry. 14) **LIMITATION OF LIABILITY; DISCLAIMER OF WARRANTIES.** Sponsor is not responsible if the Promotion cannot take place or if the Prize cannot be awarded due to delays or interruptions as a result of acts of god, acts of war, natural disasters, weather, acts of terrorism, or any other event beyond Sponsor's control. **Nothing in these Official Rules limits, excludes or modifies or purports to limit, exclude or modify any statutory consumer guarantees or any implied condition or warranty the exclusion of which from these Official Rules would contravene any statute or cause any part of these Official Rules to be void ("Non-Excludable Guarantees").** Subject to the limitations in the preceding sentence, Sponsor excludes all conditions, warranties, and terms implied by statute or general law. Except for liability in relation to a Non-Excludable Guarantee, the Promotion Parties will have no liability to any other person whether arising in tort (including, but not limited to, negligence), contract, or otherwise, for any loss, injury, or damage, whether direct, indirect, special, or consequential, arising in any way out of the Promotion.

15) **PERSONAL INFORMATION.** Personal information collected from Entrants in connection with this Promotion is subject to Sponsor's **"Privacy Notice"**, available at <https://www.procore.com/legal/privacy>. Entrant agrees that any personal information may be processed, shared, and otherwise used for the purposes and within the context of the Promotion and any other purposes outlined in these Official Rules. When you scan your Sydney Build event badge at the applicable Procore station at the Sydney Build event, your personal information will be shared with Sponsor, subject to the terms of Sponsor's privacy policy, and may be used in connection with Sponsor's business, including for marketing purposes. For Entrants who Sponsor may also use personal information to verify Entrant's identity and contact information, and to otherwise verify Entrant's eligibility to participate in the Promotion. Entrant agrees that Sponsor may send Entrant blogs, articles, specials, informational emails regarding Sponsor's business activities, and various other promotional materials. Entrant may access, review, rectify, or cancel any personal information held by Sponsor, and may elect to have Entrant's name excluded from all lists used by Sponsor, by writing to Procore State of Origin III 2025 Sydney

16) **DISPUTE; GOVERNING LAW.** These Official Rules and all matters arising out of or relating to the Promotion will be governed by the laws of the State of California, without regard for its conflicts of law provisions. To the extent permitted by law, the right to litigate, seek injunctive relief, or make any other recourse to judicial or any other procedure in case of disputes or claims arising out of or relating to the Promotion are hereby excluded and Entrant expressly waives any such rights.
